Road on the northern outskirts of the village of Travelers Rest and being known and designated as
all of lot No. 9 and one-half of lot No. 8 in a sub-division known as "Love Estates", and shown
on plat thereof made by W. J. Riddle in April 1938, the said plat being recorded in the office

feet of the street line.

land and shall be enforceable against any owner thereof or by the owner of any lot in the sub-
division from which the lot here conveyed is taken.
