

TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That S. Slater & Sons, Inc.,

a corporation chartered under the laws of the State of Delaware and having its principal place of business at Slater in the State of South Carolina for and in consideration of the sum of Twelve Hundred & No/100 (\$1,200.00) DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee/s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto William G. Inman, his Heirs and assigns:-

All that certain piece, parcel or lot of Land of the East side of Webster Street, in the Village of S. Slater & Sons, Inc., at Slater, in the County of Greenville, State of South Carolina, being known and designated as Lot no. 29 of Block D, as shown on a plat of the Village of S. Slater & Sons, Inc., made by J. E. Serrine & Company, Engineers, on July 10, 1940, which plat is recorded in the R. M. C. Office for Greenville, County, in Plat Book K, at pages 63, 64 and 65, and having, according to said plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the East side of Webster Street, joint front corner of Lots No. 29 and 30 of Block D, which iron pin is 215 feet North of the Northeast corner of the intersection of Webster and Edison Streets, and running thence with the line of Lot No. 30, N. 87-26 E. 125 feet to an iron pin, joint rear corner of Lots No. 3 and 4 of Block D; thence with the rear line of Lot No. 4, N. 2-34 W. 70 feet to an iron pin, joint corner of Lots No. 4, 5, 28 and 29; thence with the line of Lot No. 28, S. 87-26 W. 125 feet to an iron pin on the East side of Webster Street; thence with Webster Street, S. 2-34 E. 70 feet to the beginning corner.

The grantor reserves to itself, its successors and assigns, all water and sewer pipe lines, electric light and power lines, valves, fittings, hydrants, poles, wires, transformers and other apparatus used in conducting with and forming a part of the water, fire protection, electric light and power distribution and sewerage systems of the village of S. Slater & Sons, Inc. at Slater, S. C. which may be located on the lot herein conveyed, together with the right and easement, in perpetuity to go upon the land for the purpose of maintaining, repair and operation of said water, sewer, electric light and power lines, as well as for the purpose of removing and relocating said lines so as to run in or along the streets, and to erect and maintain the lines as so indicated, but this reservation does not include the individual house water and sewer pipe lines serving the house on the lot herein granted in so far as they are located on said lot. It is contemplated that there will be organized a district pursuant to the provisions of the laws of the State of South Carolina or other applicable law, and that the grantor herein reserves the right to give notice of such district to a public service corporation, or in part to such district, and in part to the grantee herein, and thereupon the grantor's responsibility, if any, with reference to the maintenance or repair of any of the utilities in said village shall cease. The grantor and grantee have read and agreed that the conveyance of the above described lot is made subject to the following restrictions:-

That the lot above described shall not be sold, leased or released to any party or person of any name.

That no mercantile establishment shall be erected, operated or maintained on the lot above described.

The above restrictions are uniform and will appear in the deeds to all lots sold by the grantor from the above mentioned plat.
