TITLE TO REAL ESTATE

STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE.

Council Boy Scouts of America have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantees, Piedmont (N.C.)
