WHEREAS, since that time R. A. Jolley and his wife, R. T. Jolley, have been acting in the capacity of Trustees of the property of Greenville Nehi Bottling Company under authority vested in them by Section 7710 of the Code of Laws of 1932, and,

WHEREAS, R. A. Jolley, as President and Treasurer, and R. T. Jolley as Vice-President and Secretary, are the only Officers of said Corporation, and R. A. Jolley and R. T. Jolley are the only Directors of said Corporation, and as Trustees of Greenville Nehi Bottling Company adopted a resolution dated February 24, 1941, under the terms of which they are authorized to convey the property to R. A. Jolley, individually.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That we, R. A. Jolley, President, Treasurer, Director and Trustee, of Greenville Nehi Bottling Company, and R. T. Jolley, Vice-President, Secretary, Director and Trustee, of Greenville Nehi Bottling Company, in the State aforesaid, in consideration of the sum of Ten (\$10.00) Dollars and other valuable considerations, to us in hand paid at and before the sealing of these presents by R. A. Jolley, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. A. Jolley, his heirs and assigns forever:

"All that certain parcel or lot of land, situate, lying and being in the County and State aforesaid on the West side of Buncombe Street just beyond the incorporate limits of the City of Greenville, and being described as follows:

BEGINNING at the northeast of a brick store building on the West side of Buncombe Street and running thence S. 57-48 W. along the wall of said store building, and in a direct line therewith one hundred twenty five and 1/10 (125.10) feet to an iron pin; thence S. 26-22 E. thirty three and 7/10 (33.7) feet to a fence post on corner of land sold by the said John B. Marshall to Jerry Cleveland and W. M. Jackson; thence along said Cleveland and Jackson line S. 46-10 E. forty and 7/10 (40.7) feet to the northwest corner of a garage building; thence N. 60-30 E.along the north wall of said garage building and in a direct line therewith one hundred eleven and 1/10 (111.1) feet to iron pin on Buncombe Street; thence along said street N. 26-50 W. seventy eight and 9/10 (78.9) feet to the beginning corner.
