DEED FOR ROAD

KNOW ALL MEN BY THESE PRESENTS, That I, J. S. Machen in consideration of the sum of ONE (\$1.00) DOLLARS to me in hand paid, receipt of which is hereby acknowledged, and for other valuable considerations, have granted, bargain, sold, and released, and by these presents do grant, bargain, sell and release unto the COUNTY OF GREENVILLE, its successors and assigns, a right-of-way, as hereinafter described on and over all lands which I may own in whole or in part.

It is the intention of the Deed to convey such parts, parcels or strips of my land that may be needed to convey a right-or-way of sections of the STAUNTON BRIDGE ROAD having the width of Thirty-Six (36') Feet, as staked out by the Engineer, except where there should be a cut or fill, may be necessary for extra width.

This right-of-way beginning at south west side of White Horse Road near Grave Yard passing over my land to a point where the new road leaves my property line; also, small strip of land between Old and New Road. It is understood that this deed covers for road purposes only.

PROVIDED THAT GREENVILLE COUNTY at it's own expense constructs a drive entrance for me beginning at point where New Road leaves my property lines and extends same to the southwest corner of my land, and constructs drive entrance to my property at this point to connect with New Road. Provided said Machen furnishes necessary right-of-way and soil for drive entrance.

IT IS AGREED AND UNDERSTOOD That the said J. S. Machen is to furnish, free of cost to COUNTY OF GREENVILLE, all necessary right-of-way and soil where road passes through his property and the COUNTY OF GREENVILLE to furnish all necessary expense to construct foad and drive entrances.
