## KNOW ALL MEN BY THESE PRESENTS:

That by a written lease dated the 12th day of December, 1940, WILLIAM H. AUSTIN as Landlord (s) therein has demised to SEARS, ROEBUCK AND CO. a corporation organized and existing under the laws of New York and qualified to do business in the State of S. Carolina, as Tenant therein, for a term from the 1st day of October, 1940, until the 1st 15th day of October April, 1949 at the rentals and upon the provision, covenants, agreements, limitations, restrictions and conditions therein contained, the premised in the City of Greenville, County of Greenville and State of S. Carolina known and described as follows:

All of that lot of land situate on the East side of Brown Street, North of North Street in the city and county of Greenville, South Carolina, and described as follows: Beginning at a stake on Brown Street and running thence along the rear line of the two lots once owned by Mrs. L. C. Boling, and which fronts North Street S. 68 E. 153 feet to a point in the line of J. F.
