King, of the State of South Carolina, hereinafter called second parties, whether one or more, has granted, bargained, sold and released, and by these Presents does grant, bargain, sell and release unto second parties, their heirs and assigns, the following described real estate, to-wit:

All that certain piece, parcel or tract of land, situate, lying and being in Austin Township, Greenville County, South Carolina, about 2 miles Northeast of the Town of Simpsonville, containing Ninety Three and 35/100 (93.35) acres, more or less, more particularly described according to a plat thereof made by H. S. Brockman, Surveyor, dated November 16, 1933, copy of which is on file with The Federal Land Bank of Columbia, bounded now or formerly on the North by Pierce Hughes and others; on the East by lands of Pierce Hughes, Acy Richards and John Holland on the South by lands of Mrs. Black and on the West by lands of Mrs. Black, and being the same lands described in a mortgage from Martha Lou Brockman to the Land Bank Commissioner, dated February 9, 1934, recorded in Mortgage Book 250, at page 26, in the office of the Clerk of Court for Greenville County.
