TITLE TO REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Whereas, R. N. Smith County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembly of South Carolina and the statute laws of said State, against Mamie McDowell Jordon (formerly Mamie McDowell) defaulting taxpayerof said County, strictly charging and commanding said Delinquent Tax Collector of said County to levy by distress and sale of the lands of the said Mamie McDowell Jordon tax defaulter, the sum of One Hundred sixty four & 坤/100 dollars including the penalties on said tax execution(s) for the year(s) 1930 through 1938 together with charges and costs thereof; and

Whereas, by virtue and authority of said warrants M. L. Ashmore the delinquent tax collector of the State and County aforesaid, did on the 14th day of March, 1940 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of April during the usual hours of sale, after due advertisement, sell the same to E. King and his heirs and assigns, the purchaser, hereinafter known as "Grantee", and the highest bidder at such sale, for the sum of one hundred sixty four & 44/100 dollars and gave a receipt for said purchase money to him; and

Whereas, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayer, or any other party interested, have failed to redeem said land so sold for taxes;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That I, M. L. Ashmore, Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of One Hundred sixty four & 1/1/100 Dollars to me paid by the said grantee E. G. King have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee E. G. King his heirs and assigns:

All that certain piece of land containing 142 acres in Dunklin Township, County and State aforesaid, known as lot number one of the lands Sarah A. Epps Jordon and described as follows: Beginning at a stake in the old Ridge Road; thence with the said Road S. 87 E. 5.28 to pin in road; thence S. 73\frac{1}{4} E. 2.27 to iron pin in road; thence N. 37 E. 11.50 to a stake; thence N. 74 W. 10.26 to stake; thence N. 77 W. 8.44 to stake on Sellman line; thence S. 12 E. 13.30 to the beginning corner.

To have and to hold all and singular the premises hereby granted, with the appurtenances, unto the said E. G. King his heirs and assigns, forever, according to the form in force and effect of the laws and usages of the State of South Carolina in such cases made and provided.
