TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, THAT, Payne Onl Company, a corporation of the State of South Carolina, with its principal place of business to Greenville, South Carolina, for and in consideration of the sum of Five Dollars (\$5.00) to it in hand paid, at and before the scaling of these Presents, by Pure Oil Company of the Carolinas, Inc., in the State aforesaid, (the receipt whereof in hereby acknowledged) have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Pure Oil Company of the Carolinas, Inc., a corporation organized and existing under and by virtue of the Laws of the State of North Carolina and domesticated in the State and Under the laws of South Carolina,

TRACT No. 1: All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carclina, just outside the corporate limits of the City of Greenville, on the West side of Rutherford Street and having the following metes and bounds: Beginning at an iron pin at the southwest corner of Grant and Rutherford Streets and running thence with Grant Street S. 81-20 W. 75.98 feet to a stake; thence S. 0-30 W. 21 feet to a stake; thence N. 81-20 E. 75.98 feet to a stake in Rutherford Street; and thence with Rutherford Street N. 0-30 E. 21 feet to the beginning corner, being shown on plat of the subdivision of the property of the Salvation of way.

TRACT NO. 3: All those ten certain lots of land situate on Rutherford Road near the junction of said Road with Paris Mountain Road, just outside the limits of the City of Greenville, in the County and State aforesaid, and more particularly described as follows:

Office for Greenville County, in Plat Book A, at page 383 to-wit: Beginning at a stake on Laurens Road at the corner of lots 60 and 59, Block D in East Park Boyte's Addition to Greenville, and running thence along Laurens Road N. 68.30 W. 60 feet to a stake at the corner of Laurens and Washington Roads; thence along Washington Road S. 58.30 W. 186 feet; thence in a straight line in a southeasterly direction and in straight line with the line between Lots Nos. 60 and 61, 88 feet, more or less, to a stake at the joint corner of Lots Nos. 61 and 60; thence with the line of lots 60 and 59, N. 48.15 E. 188 feet to the beginning corner and being part of Lot No. 59 situated on the southwest corner of Washington and Laurens Roads, fronting said Laurens Road 60 feet and being a part of one of the lots conveyed to Walter West by Arthur S. C., in Plat book "A" at page 383, to-wit: Lot No. 60 of Blook D, southeast corner of Laurens Road and Smith Avenue, fronting Laurens Road 72 feet, this being one of the lots conveyed to W. B. Harrison by deed dated October 6, 1911, and recorded in Vol. 7 at page 343, R. M. C. Office for Greenville County: This conveyance subject to the same restrictions as above stated. And heing those same identical tracts conveyed to the Payne Oil Company by Fannie C. Scott, Probate, Greenville County, by deed recorded in Book 110, Page 324, October 8, 1925, in the Office of the R. M. C. of Greenville County, South Carolina.
