All that certain piece, parcel or lot of land situate on the east side of Woodland Way, in the City of Greenville, County of Greenville, State of South Carolina, and having, according to survey of R. E. Dalton, Engineer, the following metes and bounds, to-wit:-

Beginning at an iron pin on the east side of Woodland Way, which pin is 569.3 feet northeast of the northwest corner of lot now owned by Francis 0. Beattie, and running thence with the east side of Woodland Way, N. 33-40 E. 105 feet to an iron pin on the south side of a proposed driveway; thence with said proposed drive-way, S. 59-34 E. 250 feet to an iron pin; thence with the west side of a proposed driveway S. 33-40 W. 100 feet to an iron pin; thence N. 60-48 W. 251 feet to an iron pin on the east side of Woodland Way, the point of beginning.

This being the same lot of land conveyed to me by W. C. Cleveland by deed recorded in the R. M. C. Office for Greenville County in Book 191 at page 20.

ALSO, all that certain piece, parcel or lot of land with the huildings and improvements thereon situate, lying and being on the east side of Woodland Way in the City of Greenville, County of Greenville, State of South Carolina, and having, according to plat made by R. E. Dalton, the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Woodland Way at the southwest corner of lot heretofore conveyed to the grantor herein (this being the lot above described), said point also being 105 feet in a southerly direction from the intersection of Woodland Way and a proposed 20 foot road, and running thence with the line of property of the said grantor S. 60-48 E. 251 feet to an iron pin at rear corner of lot heretofore conveyed to grantor herein; thence with the rear line of lot of grantor N. 33-40 E. 100 feet to an iron pin on south side of proposed 20 foot road herein above referred to; thence S. 26-20 W. 100 feet to an iron pin on new line of Hemlock Drive; thence still with said Hemlock Drive S. 20 W. 25 feet to an iron pin; thence with line of other property belonging to W. - (3) Said lot shall not be recut or subdivided so as to face any direction other than Woodland Way.
 - (4) This lot shall not be sold, rented, or disposed of to anyone of African descent.
 - (5) No residence shall be erected on said lot costing less than \$10,000.00.

TO HAVE AND TO HOLD ALL and singular the Premises before mentioned unto the said Mary McCall Smith, her Heirs and Assigns forever.

And I do hereby bind myself and my Heirs, Executors and Administrators to warrant and forever defend all and singular the said Fremises unto the said Mary McCall Smith, her Heirs and assigns, against myself and my Heirs and against every person whomseever lawfully claiming or to claim the same or any part thereof.
