on the West side of North Main Street, Greenville, S. C., being known and designated as Lot No. 8, and the Northern one-fourth of Lot No. 9, according to Plat of property of North Park, which Plat is recorded in Plat Book K, pages 48 and 49, and being more particularly described according to said Plat as follows:

Beginning at an iron pin, joint corner of Lots Nos. 7 and 8 on the West side of said Street; and running thence with line of said Lot N. 70-14 W. 160 feet to iron pin in line of Lot No. 23; thence with said lot S. 19-46 W. 58 feet to iron pin in line of Lots Nos. 8, 9, 22 and 23; thence continuing along the same course 14.5 feet to stake in line of property this day conveyed to E. D. Bridges; thence with his line S. 70-14 E. 160 feet to iron pin on West side of North Main Street; thence with said Street N. 19-46 E. 72.5 feet to the beginning.
