E. McClure, his heirs and assigns.

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on Stratham Street, and having the following mottes and bounds, to-wit:

Beginning on an iron pin on Stratham Street, corner of lot now or formerly owned by A. H. and R. L. Pyron, and thence running N. 85-30 W. 161.2 feet to an iron pin; thence S. 56-30 W. 30.35 feet to an iron pin; thence S. 12-20 E. 53.3 feet to an iron pin; thence N. 89 E. 187 $\frac{1}{2}$  feet to an iron pin on Stratham Street; thence with Stratham Street, 53.3 feet to the beginning corner.
