to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Charles L. Welborn

All that certain piece, parcel or lot of land, situate, lying and being in Greenville Township, State and County aforesaid, and being known and designated as rear portion of Lot No. 305 of Property of Colonia Company as per plat of Dalton & Neves made Feb. 1938 and recorded in R. M. C. Office for Greenville County, and being more particularly described as follows:

Beginning at an iron pin on the South-west side of Parker Road, joint corner of Lots Nos. 305 and 306 and running thence along the common line of Lots Nos. 305 and 306 S. 27.34 W. 219 ft. to a stake; thence N. 64.26 W. 100 ft. to a stake on the line of Lots Nos. 304 and 305; thence along the line of Lots Nos. 304 and 305 N. 25.34 E. 285.5 ft. to an iron pin on the bend of Parker Road; thence along the South-western side of Parker Road S. 34.43 E. 133.5 ft. to an iron pin, the point of beginning.
