direction four and five tenths (4.5) miles to the Town of Eastatoe, South Carolina; thence in a general northerly direction one and five tenths (1.5) miles. West Section: point where the line branches into three main branches as aforesaid, the West Section line runs in a general westerly direction along a county road one and nine tenths (1.9) miles where a tap extends in a northwesterly direction one and three tenths (1.3) miles, the main line continuing in a southerly direction one and seven tenths (1.7) miles where a tap extends in a northwesterly direction one and six tenths (1.6) miles, the main line continuing in a general southerly direction three and four tenths (3.4) miles to a point near Concord Church and the Pickens County Farm where the line branches, one branch running in a southwesterly direction seven tenths (0.7) miles where a tap extends in a southwesterly and then westerly direction six tenths (0.6) miles, the main line running ina southeasterly direction eight tenths (0.8) miles where a tap extends in a northeasterly direction seven tenths (0.7) miles, the main line continuing in a southeasterly and then southwesterly direction three tenths (0.3) miles where a tap extends in a southwesterly direction four tenths (0.4) miles, the main line continuing in a southeasterly and then northeasterly direction two and seven tenths (2.7) miles and known as the "Pickens A to Pickens B Tie Line". At the point where the line branches near Concord Church and Pickens County Farm as afore said, the other branch runs in a northwesterly direction two and two tenths (2.2) miles where a tap extends in a northerly direction eight tenths (0.8) miles to the Mt. Bethel Church, the branch line continuing in a northwesterly direction two tenths (0.2) miles; thence in a southwesterly direction three and one tenth (3.1) miles where a tap extends in a westerly direction seven tenths (0.7) miles, the branch line continuing in a general southwesterly direction nine tenths (0.9) miles; thence in a general northwesterly direction along county roads one and seven tenths (1.7) miles to Mile Creek Church and School where the line again branches, one branch runs in a general northwesterly direction one and nine tenths (1.9) miles; thence in a general northeasterly direction two and seven tenths (2.7) miles to the Town of Nine Times; thence in a general northeasterly direction one and six tenths (1.6) miles, the other branch runs in a general southwesterly direction two and eight tenths (2.8) miles where the line again branches, one branch running in a northwesterly direction six tenths (0.6) miles where a tap extends in a northwesterly direction and thence easterly one and two tenths (1.2) miles, the branch line running in a southerly direction two and one tenth (2.1) miles. At the point where the line last branches as aforesaid the other branch line runs in a southeasterly direction one and seven tenths (1.7) miles where a tap extends in a southwesterly and then westerly direction three and mine tenths (3.9) miles, the branch line continuing in a general southeasterly direction one and four tenths (1.4) miles where a tap extends in a southeasterly and then in a general southwesterly direction two (2.0) miles where an extension runs in a northeasterly direction one and one tenth (1.1) miles, the tap line continuing in a general southwesterly direction one and five tenths (1.5) miles to Kings Grove School. At the point where the tap line commences as aforesaid, the branch line continues in a general northeasterly direction three and three tenths (3.3) miles;

PICKENS B: That certain electric distribution system located solely in Pickens . County, South Carolina, and beginning at a point along United States Highway No. 178 where said highway crosses Rices Creek; thence in a southerly direction along highway No. 178 eight tenths (0.8) miles where the line branches, one branch running in a westerly direction two tenths (0.2) miles where a tap extends in a westerly direction six tenths (0.6) miles, the branch line running in a southwesterly, then northwesterly and then in a general westerly direction four and five tenths (4.5) miles, the other branch running in an easterly direction nine tenths (0.9) miles where a tap extends in a southerly direction six tenths (0.6) miles, the branch line continuing in a general northeasterly direction one and three tenths (1.3) miles where a tap extends in a northerly direction two tenths (0.2) miles and another tap extends in a southeasterly direction three tenths (0.3) miles. At the point where highway No. 178 crosses Rices Creek as aforesaid, another line runs in a northwesterly direction nine tenths (0.9) miles; thence in a southwesterly direction one and two tenths (1.2) miles where a tap extends in a southerly direction one and three tenths (1.3) miles where an extension runs in a southwesterly and then southerly direction five tenths (0.5) miles and another extension runs in a southeasterly direction three tenths (0.3) miles, the main line continuing in a southwesterly direction seven tenths (0.7) miles to the Pickens A to Pickens B Tie Line;

PICKENS N: That certain electric distribution system located solely in Pickens County and beginning at the end of the southern extension of the East Section of the Pickens A, system above described at a point seven tenths (0.7) miles southeast of Glassy Mount School; thence the Pickens A to Pickens N Tie Line runs in a southeasterly direction one and four tenths (1.4) miles where the Pickens N System begins; thence in a southeasterly direction three tenths (0.3) miles where the Pickens N system branches, one branch hereinafter described as the South Branch and the other branch hereinafter described as the East Branch.
