At the point where the line branches as aforesaid, the other branch runs in a southwesterly direction crossing highway No. 183 nine tenths (0.9) miles; thence in a southwesterly, then southerly and then southeasterly direction two and six tenths (2.6) miles where a tap extends in a northeasterly direction seven tenths (0.7) miles, the branch line continuing in a general southeasterly direction two and eight tenths (2.8) miles to a point near Fairview School where a tap extends in an easterly direction one (1.0) mile, the branch line continuing in a general southeasterly direction three (3.0) miles where a tap extends in a northeasterly and then southeasterly direction along the Southern Railroad right-of-way five and five tenths (5.5) miles to a CCC Camp near Keowee, South Carolina, the branch line running in a southeasterly direction one and three tenths (1.3) miles to highway No. 28 where a tap extends in a northwesterly direction five tenths (0.5) miles, the branch line continuing in a southeasterly direction along the Blue Ridge Railroad right-of-way two and six tenths (2.6) miles where a tap extends in a general southwesterly direction one (1.0) mile, the branch line continuing in a general easterly direction one and eight tenths (1.8) miles.

All the foregoing lines are more particularly shown on the maps attached hereto and made a part hereof and include, without limitation, all service lines and all extensions of and taps to said lines and all substations, meters, metering equipment, transformers, poles, wires, equipment, appurtenances, tenements, hereditaments, easements and other interests in land included in, appertaining to or used in connection with any of the above described lines.

All references to distances contained herein are approximate only.

TO HAVE AND TO HOLD all and singular the property, rights and interests, above granted, bargained, sold, conveyed, assigned, transferred, delivered and set over unto the Cooperative, its successors and assigns forever.

By the acceptance of this confirmatory deed, the Cooperative confirms its assumption of the obligation of the Authority to pay Three Hundred Sixteen Thousand Four Hundred Seventy Dollars and Thirty-seven Cents (\$316,470.37) of the outstanding funded indebtedness of the Authority evidenced by its First Mortgage 2.73% Bond, dated May 10, 1939, in principal amount of \$598,000, payable to the order of United States of America.


