Greenville, County of Greenville, State of South Carolina, and having, according to a survey thereof
made by Dalton & Neves, Engineers, February, 1936, the following metes and bounds, to-wit:-
Beginning at a point on the West side of North Main Street, at the Southeast corner of an
18 inch brick wall on property of the grantors herein, said point being 87 feet, 11 inches South
from the Southwest corner of the intersection of West North Street and North Main Street and munning
thence along the Southern face of said 18 inch brick wall, N. 70-02 W. 120 feet to a point on the
East side of a 12 foot alley; at the Southwest corner of the said 18 inch brick wall; thence with
the East side of said alley, S. 19-50 W. 2 feet, 1 inch to a point in line of property of grantee
herein; thence with the line of the grantee's property, S. 70-02 E. 120 feet to a point on the
West side of North Main Street; thence with the West side of said North Main Street, N. 19-50 E. 2
feet, 1 inch to the beginning corner.
The strip of land herein conveyed, together with a strip immediately South of and adjacent
thereto, belonging to the grantee herein, was heretofore set aside and used as a space for a stair-
way entrance to the second floor of the buildings on the properties of the grantor and grantee here-
in under the provisions of an agreement entered into between J. D. Gilreath and W. W. Burgiss under
date of February 6, 1900, and recorded in the R. M. C. Officefor Greenville County, S. C., in Deed
Book 22, at page 158, but the use of said space for the purpose of a stairway on said property has
now been abandoned. The grantors herein release and relinquish any and all rights which they have
in and to the use of any portion of said strip of land heretofore created and used as a space for
constructing a stairway and further release any and all rights which they have in and to the
wooden partition wall or the use thereof heretofore constructed on the property of the grantee,
which rights were acquired by us under the terms of said agreement between J. D. Gilreath and
W. W. Burgiss herein referred to, it being the intention of this deed to vest title in the grantee
to any and all portions of the land lying South of the Southern wall of the property of the grantors
and to release any and all right which we have to use said strip of land and the wooden partition
wall referred to in the said agreement. It is understood, however, between the parties here to that
the grantee shall have the right to tie on to the South wall located on the property of the grantors
and any replacement wall that may hereafter be constructed in its place.
