L. Swords land in and by a survey having the following metes and bounds, courses and distances:

Beginning at an iron pin on line of Laurel Creek Church property and running thence N. 13-30 E. 240 feet to an iron pin 25 feet from center of the Laurens Road; thence along the said Laurens Road, 25 feet from center of same, S. 63 E. 96.7 feet to an iron pin; thence S. 13-30 W. 215.3 feet to an iron pin on said Church property line; thence N. 77-15 W. 94.7 feet to the beginning corner; and containing one-half of an acre, more or less.
