W. corner lies within the limits of the Town of West Greenville, having the following metes and bounds, as shown by plat of "Property of McBee Estates," made by Dalton & Neves, Engineers, August 1937, recorded in Office of R. M. C. for Greenville County in Plat Book K page 117.
