All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

on the north side of Farr's Bridge Road, or Cedar Lane road, at the northwest corner of Hill Street, and having the following metes and bounds to-wit:

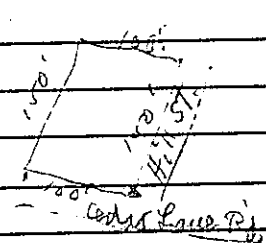

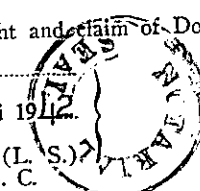
