to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Sara B. Hand, her heirs and assigns forever:-

All that certain piece, parcel or lot of land situate, lying and being on the Northeast side of Claremore Avenue, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 27, Block I, Section 5, on plat of East Highlands Estates, made by Dalton & Neves, Engineers, February, 1941, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book K, at pages 78, 79 and 80, and having, according to said plat, the following metes and bounds, to-wit:-

Beginning at an iron pin on the Northeast side of Claremore Avenue, joint front corner of Lots 27 and 28 of Block I, and running thence with the Northeast side of Claremore Avenue S. 25-42 E. 65 feet to an iron pin; thence along the Northwest edge of a 5 foot strip reserved for utilities, N. 66-44 E. 170.6 feet to an iron pin; thence along the Southwest edge of a 5 foot strip reserved for utilities N. 31-01 W. 81.9 feet to an iron pin; thence with the line of Lot 28, S. 61-06 W. 163 feet to an iron pin on the Northeast side of Claremore Avenue, the beginning corner.

This property is conveyed subject to the restrictive covenants and building restrictions applicable to this lot which are fully shown by instrument dated February 26, 1941, and recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 231 at page 1.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinafter named, and her heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

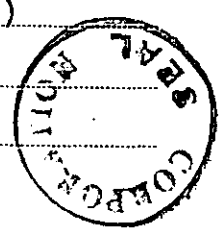

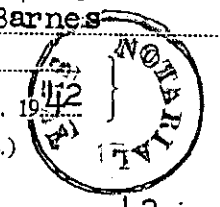
