about seven miles from Greenville County Court House and containing 8.18 acres, more or less, and
having the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin at the northeast corner of the property belonging to G. F. Thompson; thence with his line N. 77-45 W. 548 feet to a point in the new line, which point is 2 feet west of the fence erected by the Government, and said point is 1.037¹/₂ feet due east of the center line of Augusta Road; thence with said new line N. 1-03 W. (approximately parallel with said Government fence) 730 feet, more or less, to a point in the line of the property belonging to Boydton, Inc., (now Butler) which point is approximately 2 feet west of the said Government fence; thence with said Boydton, Inc., (Butler) line S. 87-10 E. 395 feet, more or less, to an iron pin in the line of the property formerly owned by C. A. Ashmore; thence along the line of said property S. 10-30 E. 838.86 feet to the point of beginning.
