## TITLE TO REAL ESTATE

STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE.

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, R. N. Smith County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County. and State by authority of the acts of the General Assembly of South Carolina and the statute laws of said State, against Mamie E. Paris defaulting taxpayer of said County, strictly charging and commanding said Delinquent Tax Collector of said County to levy by distress and sale of the lands of the said Mamie E. Paris tax defaulter, the sum of Fifty six & 98/100 dollars including the penalties on said tax execution (s) for the year(s) 1930 through 1939 together with charges and costs thereof; and

WHEREAS, by virtue and authority of said warrants M. L. Ashmore the delinquent tax collector of the State and County aforesaid, did on the 14th day of May, 1941 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of June 141 during the usual hours of sale, after due advertisement, sell the same to J. Williamson and his heirs and assigns, the purchasen, hereinafter known as "grantee", and the highest bidder at such sale, for the sum of Fifty six & 98/100 dollars and gave a receipt for said purchase money to him; and

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That I, M. L. Ashmore, Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of Fifty six & 98/100 Dollars to me paid by the said grantee, J. P. Williamson have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee, J. P. Williamson his heirs and assigns:

All that certain lot of land in the County of Greenville near the City of Greenville, in a subdivision known as "Fair Heights" having the following metes and bounds: Beginning at an iron pin on the South East corner of Bleckley Ave. and Hanover Ave. and running thence with Bleckley Ave. S. 31-20 W. 50 feet to a point; thence S. 58-40 E. 150 feet to a point; thence N. 31-20 E. 50 feet to Hanover Street; thence N. 58-40 W. with Hanover Street 150 feet to the beginning, being designated as lot number 12 of block "C", on a plat of "Fair Heights" recorded in the office of R. M. C. for Greenville County in Plat Book "F", page 257.
