- PROPOSED BUILDING RESTRICTIONS APPLICABLE TO ABERDEEN HIGHLANDS .

The following building restrictions and protective covenants are hereby imposed by the undersigned, who are the owners of all of the lots which are shown on plat of Aberdeen Highlands made by Dalton & Neves, Engineers, November, 1941, and recorded in the R. M. C. Office for Greenville County in Plat Book M, at page 37. These covenants are to run with the land and shall be binding on all parties and all persons claiming under them until January 1, 1969, at which time said covenants shall be automatically extended for successive periods of ten years unless by vote of a majority of the then owners of the lots it is agreed to change said covenants in whole or in part:-

- 1. No residence shall be erected upon any lot facing Melville Avenue as shown on said plat, costing less than \$3,000.00, and no residence shall be erected upon lots facing West Faris Road costing less than \$3,500.00.
- 2. No residence shall be erected upon said lots with a front building line less than that shown on plat of said property.
- 3. No building shall be erected upon said lots other than a residence and such buildings as may necessarily pertain there to.

4. This property shall at no time be conveyed to a person of African descent, but the owner may erect servants quarters upon said property.

If the parties hereto, or any of them, or their heirs or assigns, shall violate or attempt to violate any of the covenants herein it shall be lawful for any other person or persons owning any real property situate in said development or subdivision to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such covenants and either to prevent him or them from so doing or to recover damages or other dues for such violation.

Invalidation of any one of these covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and effect.
