Hopkins the then delinquent tax collector of the State and County aforesaid, did on the 12th day of November 1937 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of Dec. during the usual hours of sale, after due advertisement, sell the same to The Forfeited Land Commission and their assigns, or successors, the purchasers, hereinafter known as "grantees", and the highest bidder at such sale, for the sum of three hundred ten & 40/100 dollars and gave a receipt for said purchase money to them; and

Whereas, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayers, or any other party interested, have failed to redeem said land so sold for taxes;

Now, Therefore, know all men by these presents that I, M. L. Ashmore Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of three hundred ten & 40/100 Dollars to me paid by the said grantees, The Forfeited Land Commission have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantees, Forfeited Land Commission their assigns; or successors:

All that lot, piece or parcel of land known as 91 acres of land in Dunklin Township, 2-B School District. This is part of the land deeded to Alex Chapman 1907 by Anna T. Campbell, (Vol. TTT, page 322) and by E. Inman, Master 1919, (Vol. 59, page 44) For a more particular description reference is made to the above deeds on file in R. M. C. Office for Greenville County.

Together with all and singular the Rights, Members, Hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining.

To Have and to hold all and singular the premises hereby granted, with the appurtenances, unto the said Forfeited Land Commission their assigns, or successors, forever, according to the form in force and effect of the laws and usages of the State of South Carolina in such cases made and provided.
