M. Moore, Now, Therefore,

KNOW ALL MEN BY THESE PRESENTS That We, George Henry Moore, whose wife is Frances DeBerry Moore, Thomas R. Moore (erroneously listed in the petition to prove the will in the Probate Court as Thomas M. Moore), whose wife is Rosa Green Moore, May Moore, Bazil M. Moore, unmarried, and Furman Yates Moore, unmarried, these with the grantee being all the children of Susanna Mingus Moore and B. M. Moore, all of the State and County aforesaid, in consideration of the premises above set forth, of similar deeds executed in partition of said estates, and of One (\$1.00) Dollar, to each of us in hand paid by Paul Alexander Moore, receipt of which is hereby acknowledged, in the State aforesaid, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Paul Alexander Moore:

All that tract of land in Greenville County, South Carolina, which is a part of the estates of our mother, Susanna Mingus Moore, and our father, B. M. Moore, as is more fully shown by plat made by W. J. Riddle August 1932, and attached to the will of our father, B. M. Moore, in the Probate Record, to which reference is hereinabove made, on which plat is is shown as tract 1, containing 31.09 acres. From this plat, the following metes and bounds are taken: Beginning at a stone on Gresham's line and running thence S. 72 E. 759 feet to a stone on said line, and continuing Gresham's line to the line of Corrie Bramlett's land, and that with her line N. 43-40 E for a total distance of 1705 feet to a point in the public road; thence following the public road as the line between this tract and tracts 2, 3, 4 and 5, the following courses and distances: S. 8-30 E. 403 feet to joint corner tracts 2 and 3; thence continuing in the same course 100 feet to a point in said public road; thence S. 4-30 W. 250 feet to joint corners tracts 3 and 4, thence continuing same direction 50 feet to a point in said public road; thence S. 17 W. 424 feet to joint corners of tracts 4 and 5; thence S. 29-30 W. 261 feet to point in public road; thence S. 40-45 W. 396 feet to point where the public road crosses the branch, being the joint corners of tracts 5 and 6; thence following the creek as the line, bounded by lands of P.
