Line near Gantt Station to the Army Air Base on the Augusta Road, upon, along and over that certain belt, strip or right of way 70 feet in width upon which said spur track has already been completed and is now in operation, extending upon, along, over through and across that tract of land containing 25 acres, belonging to the grantors and situate in said County and State aforesaid and being more particularly described as follows:
