All that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina and being known and designated as Lot 263 of the property of Colonia Company as per plat of Dalton & Neves, made February, 1938 and recorded in Plat Book J, Pages 190 and 191 and being more particularly described as follows:

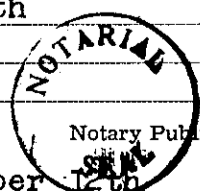
