being known and designated as the Eastern one-half of Lot No. 14, Block A, of the Buist property, according to Plat recorded in Plat Book C, page 10, R. M. C. office for Greenville County, being situate on the North side of Mountain View Avenue, and more particularly described according to survey of R. E. Dalton, September 10, 1942, as follows:

BEGINNING at an iron pin on the North side of said Avenue, corner of Lot No. 15, now owned by the grantee; thence N. 10-00 E. 287.2 feet to stake on an Alley; thence with said Alley N. 72-40 W. 46.4 feet to stake; thence S. 11-42 W. 293.8 feet to iron pin on said Avenue; thence with said Avenue S. 89-15 E. 55 feet to the beginning.
