KNOW ALL MEN BY THESE PRESENTS, That Conyers & Gower, Inc.

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Three Hundred Eighty-five and no/100 (\$385.00) DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... (s.) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Mazie Mayer, her Heirs and Assigns, forever:-

All that certain piece, parcel or lot of land situate, lying and being on the Southwest side of Laurens Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 20, of Block B, on plat of East Highlands Estates, made by Dalton & Neves, Engineers, April, 1940, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book K, at pages 35 and 36, and having, according to said plat, the following metes and bounds, to-wit:-

Beginning at an iron pin on the Southwest side of Laurens Road at joint front corner of Lots No. 19 and 20, of Block B, said pin also being 75 feet in a Northwesterly direction from the intersection of Laurens Road and Wait Street, and running thence with the line of Lot No. 19, S. 16-11 W. 212.2 feet to an iron pin on the Northeast side of an alley; thence with the Northeast side of said alley, N. 73-49 W. 70 feet to an iron pin; thence with the line of Lot No. 21, N. 16-11 E. 239.4 feet to an iron pin on the Southwest side of Laurens Road; thence with the Southwest side of Laurens Road, S. 52-32 E. 75 feet to the beginning corner.

The above property is conveyed subject to the following building restrictions:

- (1) The lot herein conveyed shall be used for residential purposes only.
- (2) The lot herein conveyed shall never be sold, rented or otherwise disposed of to negroes or persons of African descent.
- (3) No residence shall be erected on said lot costing less than \$2,500.00.
- (4) The building line as shown on the recorded plat and also other restrictions shown on said plat are to be strictly adhered to.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee... (s.) hereinabove named, and her heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... (s.) hereinabove named, and her heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

Gower, as President and Caroline C. Gower, Assistant Secretary, on this the 2nd day of February, in the year of our Lord one thousand nine hundred and forty-three, and in the one hundred and sixty-seventh year of the Sovereignty and Independence of the United States of America.

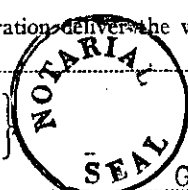
