A certain piece, parcel, or tract of land, lying partly in Polk County, State of North Carolina, partly in Spartanburg County, State of South Carolina, and partly in Greenville County, State of South Carolina, bounded and described as follows:

Beginning at an iron pin in the road which leads from Tryon to the residence property of Rev. C. P. Burnett, said iron pin being approximately thirty feet east of the Spartanburg County-Greenville County line and running thence with said road which is also known as the old Tryon and Landrum road, three calls as follows: North 36 degrees 30 minutes West 300 feet to a stone, an original corner of the George Bridgeman 10-acre tract; North 36 degrees 30 minutes West 265 feet to the North Carolina-South Carolina State line; North 56 degrees West 250 feet; thence leaving said road and running with the outside lines of said George Bridgeman 10-acre tract, 4 calls as follows: North 59 degrees 20 minutes East 120 feet to a stake; North 78 degrees 30 minutes East 100 feet to an iron pin; North 22 degrees East 406 feet to an iron pin; South 66 degrees East 840 feet to a stone, corner of said George Bridgeman 10-acre tract; thence with the line of the Caroline Bridgeman or Will Bridgeman 13-acre tract, 6 calls as follows: South 66 degrees East 210 feet to an iron pin; North 31 degrees East 53 feet to a stone; North 84 degrees 25 minutes East 405.5 feet to a stone; South 13 degrees East 50 minutes West 750 feet to a stone; North 64 degrees 50 minutes West 688 feet to an iron pin; South 55 degrees 50 minutes West 494 feet to the beginning.
