All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

in Ward Two of the City of Greenville, on the east side of McGee Street, and having the following metes and bounds, to-wit:

Beginning at a point on the east side of McGee street, at the corner of lot now or formerly belonging to Groverman, which point is 100 feet north from the northeast corner of the intersection of North Street and McGee Street, and running thence with McGee Street approximately N. 20-48 W. 50 feet, 5 inches, to a point; thence on a line about parallel with North Street, 105 feet, more or less, to a stake; thence on a line about parallel with McGee Street, 50 feet, 5 inches, more or less, to the line of the property now or formerly belonging to Groverman; thence with Groverman's line approximately N. 77-03 W. 96 feet to the beginning corner.
