TO ALL WHOM THESE PRESENTS SHALL COME:

I, E. INMAN, Master in and for the County aforesaid, SEND GREETINGS:

WHEREAS, Hardy Wright, Executor of the last Will of Anna Greer

on or about the 5th day of February in the year of our Lord nineteen hundred and forty-three exhibited his complaint in the Court of Common Pleas, for the County aforesaid, against Emanuel Greer, et al.

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 14th day of April, 1943, and such proceedings were had therein as resulted in a Decree

of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for the County aforesaid, to Altha J. Goodlett, Lula Jackson, Mable J. King, Anna E. Jackson and Lillian Jackson

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgement Roll No. E-9568)

NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these Presents, DO GRANT, convey, and release unto the said Altha J. Goodlett, Lula Jackson, Mable J. King, Anna E. Jackson and Lillian Jackson

"All that certain tract of land in O'Neal Township, Greenville County, State of South Carolina, containing 2.50 acres, more or less, and being known and designated as Tract No. 11 of the John M. Greer and Frances Jane A. Greer Estates, as shown on a sub-division and plat made by H. S. Brockman, Surveyor, on December 1-2, 1941, which plat is of record in the R. M. C. Office for Greenville County in Plat Book M, at page 67, and having, according to said plat, the following metes and bounds and courses and distances, to-wit:

Beginning at an iron pin at joint corner of tracts 10 and 11 and in line of land of Sloan Martin Estate and running thence along the line of the Sloan Martin Estate S. 89-45 W. 278 feet to a stone; thence S. 2-10 W. 450 feet to an iron pin at corner Tract #12; thence along the line of Tract #12 S. 89-30 E. 252.7 feet to a point in line of Tract #9; thence along the line of Tract #9 N. 7-42 W. 195.5 feet to corner of lot #10; thence along the line of Lot #10 N. 16-20 E. 272.5 feet to iron pin at the beginning point."

The above land is conveyed to the Grantees pursuant to the Order of Court in the above entitled action and is conveyed without any money consideration, the purpose being to obtain partition of this and other lands by and between the parties to this action.
