D. Plamondon, Jr., his heirs and assigns, forever, the following described real estate:

All of the certain piece, parcel or tract of land, situated, lying and being in Spartanburg and Greenville Counties, State of South Carolina, but particularly and expressly excepting and excluding the area in Polk County, North Carolina, lying within the boundaries hereinafter mentioned (said area in Polk County being conveyed by a companion deed of even date from St. Luke's Hospital, Inc. to A. D. Plamondon, Jr. and Ruth Wilks Plamondon, his wife, as tenants by the entirety, bounded and described as follows:

Beginning at an iron pin in the road which leads from the Town of Tryon to the residence property of the Rev. C. P. Burnett, said iron pin being approximately thirty feet east of the Spartanburg County-Greenville County line, and running thence with said road, which is also known as the old Tryon and Landrum road, three calls as follows:
