known and designated as Lot No. 3 on plat of property of Shirley L. Styles made by Dalton & Neves  
October 1940, recorded in the R. M. C. Office for Greenville County in Plat Book L, page 151, and  
having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the Northern side of Carroll Street, 72.7 feet West of the  
Northwestern intersection of McPherson Lane and Carroll Street, and running thence with Carroll  
N. 73-22 W. 72 feet to an iron pin, joint Southern corner of Lots Nos. 3 and 4; thence with the
