TITLE TO REAL ESTATE

STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE.

KNOW ALL MEN BY THESE PRESENTS: That I, R. M. Caine, of said County and State for the sum of One (\$1.00) Dollar to me in hand paid by the City of Greenville, S. C. the receipt of which is hereby acknowledged, do hereby grant unto the City of Greenville it successors and assigns the right privilege and easement to go in and upon that tract or lot of land situated in City of Greenville, S. C., the conveyance to me of which is recorded in the office of R. M. C. for Greenville County in Deed Book _____ at page ____ said property being bounded by lands of Caine, M. D. Earle Estate, L. A. Moseley and a Street known as Forest View Drive and known as lot No. ____ as shown on the plat of Forest Hills made by T. C. Adams in Sept. 1936, and recorded in the office of R. M. C. of Greenville County in Plat Book D, at page 206, with the necessary equipment and materials, and to construct therein and/or thereon a pipe line with manholes and any or all necessary adjuncts thereto for the conveyance of sewage through the premises above described, together with the right to enter in and upon said premises at any or all times with the necessary quipment and/or materials for the purpose of inspecting and making repairs and alterations thereon of said pipe line, together with the right to cut away and keep clear of said pipe lines all trees and other obstructions that may in any way endanger the life or proper operation of same.

It is understood and agreed that the easement herein granted shall extend throughout the property of the grantor about _____ feet, and during construction, maintenance or repairs, and shall be 15.0 feet on each side of the center line of the pipe line, and at all other times should be of a width to accommodate the sewer pipe line, and that the damage for which the City of Green-ville or its assigns may be held liable shall be confined to that arising from the use of this strip only and nothing beyond.

It is further agreed that this easement is to be used only during the construction or repair of said pipe line and with the exception of the right of the City of Greenville, its agents, servants, employees and assigns, to inspect said pipe line and to enter at any point and make repairs, the owner has the same privilege as he now has to cultivate and use the land, provided, however, this shall not apply to such part wherein the top of the pipe is less than eighteen (18) inches underground.
