WHEREAS, we, the undersigned heirs at law of said Mrs. Josie Miller are desirous of selling and conveying the real estate, now therefore,

KNOW ALL MEN BY THESE PRESENTS: That we, James Hudgens, individually and as Administrator of the Estate of Josie Miller, deceased, Thomas Hudgens, Lula McClellan, Zettie McNeely, Homer Kelly, Barney Kelly, Pearl K. Rice, and Grace K. Duncan, in the State aforesaid, in consideration of the sum of Two Thousand, One Hundred and no/100 --(\$2,100.00) Dollars to us in hand paid at and before the sealing of these presents by Virginia C. Hinson (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Virginia C. Hinson, her heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Ward Three of the City of Greenville, on the south side of Rhett Street, and being more particularly described as follows, to-wit:

Beginning at an iron pin on the south side of Rhett Street at the corner of lot now or formerly belonging to M. E. Carpenter, which point is 87 feet, 9 inches from the southeast corner of the intersection of Markley Street and Rhett Street, and running thence along the south side of Rhett Street, N. 71-45 E. 30 feet, more or less, to an iron pin, corner of lot now or formerly belonging to D. E. Wooten; thence along the line of that lot, S. 19-15 E. 130 feet, more or less, to an iron pin; thence along the line of lots formerly belonging to Mrs. M. E. Hinson, and her heirs and assigns, against ourselves, our heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
