on the west side of the Greenville-Piedmont Highway, and being known and designated as all of Lot No. 8, of the property of W. W. Griffin, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book J, at page 55; and a portion of Tract No. 12, of the property of C. C. Good, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book G, page 223, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of the Greenville-Piedmont Highway at a point 100 feet south from the joint corner of Tracts Nos. 11 and 12, Plat Book G, 223, and running thence along the west side of said Highway, S. 16-20 W. 142.2 feet, more or less, to an iron pin on the west side of said Highway at the joint corner of Lots No. 8, of the Griffin property (Plat J, 55) and Tract No. 12, of the Good property (Plat G, 223), and continuing still with the west side of said Highway, S. 17-45 W. 160 feet to an iron pin, joint corner of Lots Nos. 8 and 9; thence along the joint line of said lots, N. 85 W. 312 feet, more or less, to an iron pin on the right-of-way of the C. & G. Railroad; thence along the line of said right-of-way, N. 28-45 E. 160 feet to an iron pin, corner of Tract No. 12, of the Good property; thence still with said right-of-way, N. 29-00 E. 206.4 feet, more or less, to an iron pin at a point 100 feet south of the joint corner of Lots Nos. 11 and 12, of the Good property; thence along the line of lot of H. H. Williams, S. 77 1/2 E. 250 feet, more or less, to the beginning corner on the said Highway.

The above described lot is composed of three lots deeded to me as follows:

  - (3) Part of Lot No. 12, of the Good property, fronting 142 feet, more or less on the Highway, by Oakvale Land Company by deed dated July 7, 1936 and recorded in Vol. 185, page 226;
