TITLE TO REAL ESTATE

NORTH CAROLINA

WAKE COUNTY

THIS DEED made this 28th day of May, 1942, by T. E. Gill, party of the first part, to Adeline L. Gill, party of the second part, both parties being residents of Wake County, North Carolina;

WITNESSETH:

THAT the said T. E. Gill for and in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration to him paid by the party of the second part, the receipt of which is hereby acknowledged, has bargained, and sold and by these presents, does hereby convey, bargain and sell unto the party of the second part, her heirs and assigns, all of his right, title and interest in and to certain lands, the first two lots being located in the outskirts of the Town of Zebulon, Wake County, North Carolina, and the last two lots being located in the State of South Carolina, which property is fully described as follows:

FIRST LOT: Beginning at a stake at the Northeast corner of the intersection of Wakefield Street and Barbee Avenue in the Town of Zebulon and running thence in a Northerly direction along the Eastern line of said Wakefield Street 175 feet to an alley; running thence in an Easterly direction along the Southern line of said alley 50 feet to a stake; running thence in a Southerly direction and parallel to Wakefield Street 175 feet to a stake; on Barbee Avenue; running thence in a Westerly direction to a point on Barbee Avenue; running thence in a Westerly direction to a point on Barbee Avenue 50 feet to the point of Beginning, containing Lots 57 and 58 in the Plan of Zebulon, Block 33, see Map recorded in Book of Maps 1885, Page 68, Wake County Registry.
