KNOW ALL MEN BY THESE PRESENTS, That I, John M. (Jack M.) Gibson, now in the armed forces of the United States, heretofore on May 20th, 1943 made J. W. Tyson, Sr. my Attorney-in-Fact, intending under the instrument executed to give him power and authority to supervise, manage and control, and if in his judgment proper, to grant, bargain and sell any or all of my property, real and personal and wheresoever situate, and whether owned by me individually or in common with others, and generally manage and supervise all of my business affairs that might arise during the currency of the Power.

I own as a devisee of T. B. Gibson, dec. an undivided interest in three hundred sixty-five (365) acres of land in Saluda Township, Greenville County, S. C., it being the same tract of land more fully described in a deed from A. G. New to T. B. Gibson dated December 15, 1917, and recorded in Deed Book 43 at page 272 R. M. C. Office for said Greenville County.

I do hereby specifically authorize and empower the said J. W. Tyson, Sr. as my Attorney-in-Fact for me and in my place and stead to grant, bargain and sell my interest in said property, and for me and in my name to make, execute, acknowledge and deliver a good and sufficient deed for said property, and I do hereby expressly ratify and confirm the deed of said J. W. Tyson, Sr. as my Attorney-in-Fact to H. B. Gosnell, dated September 11, 1943.

This instrument is intended to supplement the Power of Attorney heretofore executed by me to the said J. W. Tyson, Sr. on May 20, 1943, so as to extend the authority of my Agent to act for me, and if in his judgment it be to my benefit to grant, bargain and sell and in my name to make, execute, acknowledge and deliver good and sufficient deeds to any of my property or interest in property wheresoever situated. Aside from property in Marlboro County and Greenville County I own an undivided interest in certain real estate in Chester County, and this Power is expressly extended to embrace that property.

I do hereby expressly confirm and ratify all acts of my attorney heretofore done by virtue of the authority of my Power of Attorney heretofore executed.
