

TITLE TO REAL ESTATE—G. T. 204

KNOW ALL MEN BY THESE PRESENTS, That

Colonia Company

Whereas, on the 22nd day of July, 1943, the grantor herein executed a deed to the grantee herein conveying the property hereinafter described, said deed being recorded in the R.M.C. Office in deed book 255 at page 135, in which deed there was an error in the description of the property therein conveyed, and it being the purpose of this deed to correct said description,

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of One and no/100 DOLLARS, and the correction of said deed,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto D. F. Williams, and his heirs and assigns,

all that piece, parcel, lot or tract of land, situate, lying and being in Greenville County, State of South Carolina, and having the following metes and bounds, according to a re-survey of the Property of D. Frank Williams made by W. J. Riddle, Surveyor, June 4, 1943, to-wit:

Beginning at an iron pin on the northwest side of Berkley Avenue, joint corner with the property now owned by the Grantee herein; thence N. 32.58 E. 387.4 feet to an iron pin on the northwest side of Berkley Avenue; thence N. 22.44 E. 114.6 feet to an iron pin; thence N. 7.28 E. 159.6 feet to an iron pin; thence N. 43.38 W. 83.9 feet to an iron pin on the eastern side of a 15-ft. alley; thence across said alley, S. 46.41 W. along the northwest side of a 10-foot alley 1107.3 feet to an iron pin at a bend in said alley; thence S. 89.04 W. along the north side of said alley 80 feet to an alley leading into the Buncombe Road; thence along the southeast side of said alley leading into the Buncombe Road S. 55.39 W. 170 feet to a point on the northeast side of the Old Buncombe Road; thence S. 63.22 E. 366.4 feet along Buncombe Road to a point; thence N. 32.58 E. 200 feet to a point on the southeast side of a 10-foot alley; thence N. 32.58 E. across said 10-foot alley to a point on the north side of said alley; thence S. 57.32 E. 25 feet along said alley to a point; thence N. 32.58 E. 195 feet to a point; thence S. 57.32 E. 175 feet to a point on the northwest side of Berkley Avenue; thence N. 32.58 E. along the north side of Berkley Avenue 65 feet to the corner of the lot owned by the Grantee herein; thence N. 57.32 W. 175 feet to a point; thence N. 59.26 E. 112.2 feet to a point; thence S. 57.32 E. 125 feet to the beginning corner.
