POWER OF ATTORNEY TO CONVEY REAL AND PERSONAL PROPERTY, ETC.

To pay off and change at any time, any loans existing on any of my real or personal property in Greenville County, said State, to create and place new loans thereon, on such terms and in such amounts as may be necessary and advisable, to sign, seal, execute and deliver any and all proper and requisite writings and do any and every other act, deed or thing legal, thereabout.

At any time, to offer for sale, grant, bargain, sell, release and convey by appropriate documents and papers, any and all real and personal property, or any interest therein or portion thereof, which I now own in Greenville County, said State or elsewhere, or which I may in any way hereafter acquire and wheresoever, for such price and on such terms as she may deem fair and reasonable, to sign, seal, execute and deliver to purchaser or purchasers any and all proper and requisite writings and documents and do any and every other act, deed or thing legal, thereabout.
