All that certain piece, parcel or tract of land situate, lying and being in Bates Township, Greenville County, South Carolina, on the northeast side of what is now known as the Greenwille & Northern Railway, (formerly C. K. & W. Rwy.), and on both sides of the new White Horse Road, and more particularly described as follows: Beginning at a point on the old White Horse Road at Clarence Timmons' corner, and running thence in a southwesternly direction along said old White Horse Road to the Greenville & Northern Railway; thence along the said Greenville & Northern Railway in a southeasternly direction to corner of Faytte Sammons' land; thence along Sammons' line in a northeasternly direction to a rock corner on the Clarence Timmons' line, four (4) chains, more or less; thence in a northwesternly direction along Clarence Timmons' line to the beginning corner on the old White Horse Road, containing Two and one-half $(2\frac{1}{2})$ acres, more or less subject, however, to the Right of Way of the said Greenville & Northern Railway, but is to include the portion now occupied and used by and heretofore conveyed to said Greenville & Northern Railway as and for a Right of Way, should the said Railway ever at any time abandon or lose the right to same; this being the same tract of land known as the Shelton Land and same conveyed to said Alexander McCauley by A.
