All that certain piece, parcel or lot of land situate in the City of Greenville,
County of Greenville, State of South Carolina, on the East side of Anderson Street, and being
known and designated as Lot 8, Block 4, page 73 of the City Block Book, and having the following
metes and bounds, to-wit:-

Beginning at an iron pin on the East side of Anderson Street, corner of lot of Frank
Earle which point is approximately 81.9 feet in a southerly direction from the intersection of
Anderson Street and Pendleton Street, and running thence along the east side of Anderson Street in
a southerly direction 71.5 feet to an iron pin corner of lot of Stephen which point is approximate
ly 82.9 feet north of the intersection of Vardry Street; thence along the Stephens lot in a south-
easterly direction 77.6 feet to an iron pin; thence in an easterly direction along line of Stephens
and Mary A. McKie lots 23 feet to an iron pin, near corner of lot of Frank Earle; thence in a
