SEPARATION AGREEMENT

Shepherd from any and all duty to her by reason of their marital relationship including the duty of living with her and of furnishing and supplying to her support and maintenance and any and all duties customarily due or performed by a husband.

It is understood and agreed that on and after this date each of the undersigned shall be at liberty to keep company with such friends as they may desire without objection, interference or molestation from each other.

It is further understood and agreed that the automobile stands in the name of and is in the possession of the said E. C. Shepherd shall remain his sole and separate property, likewise the furniture now in possession of the said E. C. Shepherd shall remain his sole and separate property.

It is further understood and agreed that in the event either of the parties here to desire a divorce the other party will not offer any objection thereto, but on the contrary will accept service of any petition or application for divorce and will waive any question as to the jurisdiction of the court in any state in which said application may be made to grant said decree of divorce.
