All that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina.
containing 60 3/4 acres, more or less, lying on waters of North Saluda River and beginning at a stone
3x on Gap Creek Road; thence S. 29 3/4 W. 1.00 to a stone 3x formerly a pine; thence S. 22 1/2 W. 20-12
to a stone 3x; thence S. 27 W. 13-78 to pine 3x; thence 87 3/4 W. 22-64 to a black oak 3x; thence S. 55 E. 16-25 to a pine 3x; thence 38 1/2 E. 7-85 to stone 3x; thence N. 40 1/2 E. 32-50 to Stone 3x in old
line between Bates Place and Moore Place; thence with said line S. 72 1/2 E. 2-56 to a stone 3x; thence
N. 22 1/2 E. 1890 to stone 3x on the road; thence with said road to the beginning corner.
