POWER OF ATTORNEY.

FURTHER, I do authorize my aforesaid attorney-in-fact to perform all necessary acts in the execution of the aforesaid authorizations and generally to do any and all acts on my behalf on any other matter or thing pertaining or belonging to me with the same validity as I could effect, if personally present; hereby ratifying and confirming whatsoever my said attorney shall and may do, by virtue hereof, in the premises; including power to sign my name on any document requiring same, with full force and effect and with the same validity as I could effect if personally present.
