All that piece, parcel or lot of land in Glassy Mountain (A small portion in Spartanburg County) Township, Greenville County/State of South Carolina.

being a part of the land shown on plat made by J. H. Atkins, surveyor, for T. A. Hyder, dated July 30, 1943.

Beginning at a stake on Emory's Creek at corner of lands of Lonny Penfield and Tom West and running thence along line of lands of said Tom West S. 76-23 W. 391 feet to a stone at corner of Carpenter's land; thence along line of said Carpenter's land S. 29-00 E. 143 1/4 feet to a stake in an old road; thence N. 49-30 E. 457 feet to a stake on Emory's Creek; thence N. 52-15 E. 779 feet to a stake in field, thence N. 42-41 E. 852 feet to a stake on ditch bank; thence N. 85-03 E. 103 6/10 feet to a point in Rutherfordton Road; thence along said road N. 15-00 E. 462 feet to a point in said road; thence continuing along said road N. 16-30 E. 533 feet to a stake in old road; thence S. 87 1/2 E. 80 feet to a stake; thence N. 2-2 E. 195 feet to an iron pin; thence crossing Rutherfordton Road and another road N. 87-15 W. 181 1/4 feet to a stone at corner of lands of Bart Tallant Estate and Lonny Penfield; thence along line of lands of Lonny Penfield S. 7-10 E. 501.5 feet to a stone pile; thence S. 24-30 W. 660 feet to a stake; thence S. 57-30 W. 325.5 feet to the beginning corner.

Containing 83.6 acres, more or less.

The above boundary includes 3/10 of an acre lying on the east side of Rutherfordton Road, which has been sold to T. D. West by deed dated September 10th, 1943, with the following description; Beginning on an iron pin, Gary Cothran corner (Part of Tallant Estate) thence N. 87-15 W. 36 feet to road; thence S. 21-38 W. 204.5 along road thence S. 87 1/2 E. 105 feet to a stake on east side of branch; thence N. 2-22 E. 195 feet to iron pin beginning corner, containing 3/10 of an acre, more or less.
