all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

Being known and designated as part of lots Nos. 87 and 88, as shown on plat of City View Annex, revised April 1927, according to survey by W. J. Riddle, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book G, page 155, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Agnew Road, said pin being 162 feet in an easterly direction from the northwest corner of Lot No. 87, and running thence N. 53-40 E. 200 feet to an iron pin; thence N. 49-20 W. 78 feet, more or less, to an iron pin in line of Lot No. 87 being the outside property line of the land shown on the above mentioned plat; thence along said outside property line S. 73-30 W. 62 feet, more or less, to an iron pin; thence S. 53-40 W. 148 feet, more or less, to an iron pin on the north side of Agnew Road; thence along said north side of Agnew Road S. 49-20 E. 100 feet to the beginning corner.
