

## EXECUTOR'S TITLE TO REAL ESTATE.

ALL THE ESTATE, right, title, interest, property possession, claim and demand whatsoever, both in law and equity, which the said Testator had at the time of his decease; and which the said party of the first part has by virtue of said last Will and Testament of T. H. Reid, deceased, of, in and to:

All that certain piece, parcel or lot of land situate, lying and being at Gowansville, Greenville County, South Carolina, being known and designated as Lot No. 12 on plat of the property of the T. H. Reid Estate recorded in the R. M. C. Office for Greenville County at page 101, Vol. M. Said lot containing 33.4 acres, more or less and having the following metes and bounds. Beginning in a road and running S. 83 E. 528 feet to a point; thence S. 6 W. 179 1/4 feet to a point in the Tugaloo Road; thence along said road N. 74.40 E. 1120 feet to a point in the Tugaloo Road and side road; thence N. 14.20 E. 118 feet to a point; thence N. 10 W. 156 feet to a point; thence N. 17 E. 287 feet to a point; thence N. 41 E. 145 feet to a point; thence N. 66 E. 292 feet to a point; thence N. 280 feet to a point; thence N. 35.40 E. 338 feet to the beginning corner. 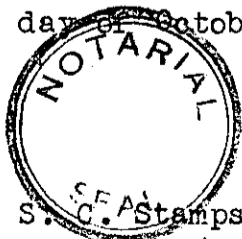
