

## EXECUTOR'S TITLE TO REAL ESTATE.

THIS INDENTURE, Made this 21st day of October in the year of our Lord one thousand nine hundred and Forty-four between C. T. Reid, as Executor of the last Will and Testament of T. H. WITNESSETH, That the said party of the first part, by virtue of the authority to him given in and by the said last Will and Testament, and in consideration of the sum of Two Hundred Five and no/100 (\$205.00) Dollars to him Paid by the said party of the second part (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these Presents does GRANT, BARGAIN, SELL AND RELEASE unto the said party of the second part his Heirs and Assigns forever, ALL THE ESTATE, RIGHT, title, interest, property possession, claim and demand whatsoever, both in law and equity, which the said Testator had at the time of his decease; and which the said party of the first part has by virtue of said last Will and Testament of T. H. Reid deceased, of, in and to:

All that certain piece, parcel or lot of land situate, lying and being at Gowansville, Greenville County, South Carolina, containing 2.6 acres, more or less, and being known and designated as Lot No. 5 on the plat of the property of the T. H. Reid Estate, recorded in R. M. C. Office for Greenville County, at page 101, Vol. M. Said lot fronting 200 feet on the Tugaloo Road and running back a distance of 594 feet on one side and 562 feet on the other side and a width of 200 feet in the rear. Said lot bounded by property of T. W. Petty and Lots Nos. 6, 3 and 4 of the T. H. Reid Estate and by the Tugaloo Road.

Whereas, on or about the 3rd day of October, 1944, C. T. Reid, as Executor of the T. H. Reid Estate advertised for sale at public auction through the Metcalf Realty Company all of the real property owned by the said estate in and near Gowansville, South Carolina, and whereas Shreve D. Jones was the highest bidder for the said property under the terms announced on the grounds for the sale of the said property.
